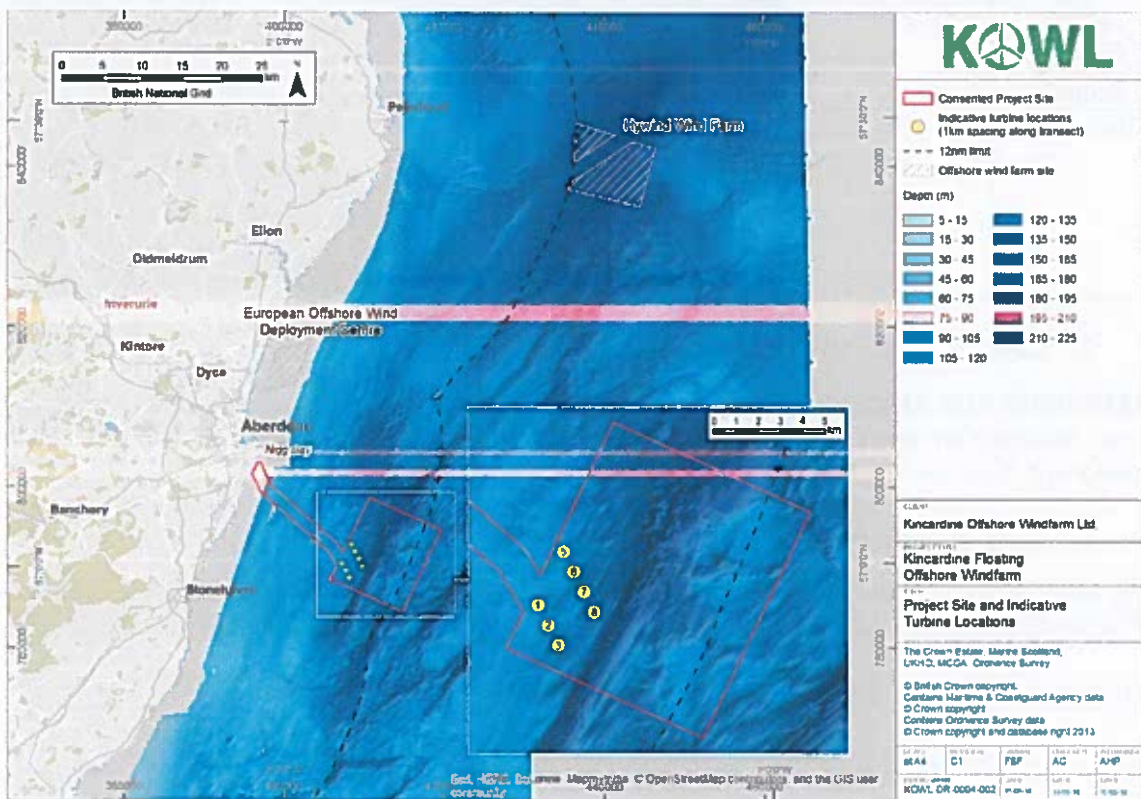



Figure 1: Project Site and Indicative Turbine Locations (NOT TO BE USED FOR NAVIGATION)
